FURTHER RESOLVED THAT, Trustee Eric R. Balancio shall assist the OIC-GM whenever necessary.

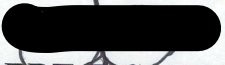

*(Resolution Approving the Extension of Appointment of the Office-in-Charge,
Office of the General Manager)*

Satinitigan as Officer-in-Charge, Office of the General Manager (OIC-GM), effective March 1, 2025, the Board acknowledges the accomplishments, albeit a short period of time, of the OIC-GM, with the assistance of Trustee Eric R. Balancio;

WHEREAS, the Personnel Committee is still in the process of its executive recruitment for the General Manager Position;

WHEREAS, there is a need to appoint an Office-in-Charge until the Personnel Committee recommends a qualified candidate to the Board for approval;

NOW, THEREFORE, for and in consideration of the foregoing premises, **BE IT RESOLVED**, as it is hereby **RESOLVED**, that the Board of Trustees approves the extension of the appointment of **Trustee Expedito C. Satinitigan** as Officer-in-Charge, Office of the General Manager, for a period not less than six (6) months;

FURTHER RESOLVED THAT, Trustee Eric R. Balancio shall still assist the OIC-GM whenever necessary;

FURTHERMORE, RESOLVED THAT, Trustee Satinitigan shall receive a monthly compensation of P80,000 as Officer-in-Charge, Office of the General Manager, in addition to his honoraria as Trustee, while Trustee Eric R. Balancio shall receive an additional allowance of P40,000.00 on top of his honoraria as Trustee;
