ELECTION CODE OF 2024

1. The Regional Representative Assembly (RRA) shall be held not later than thirty (30) days before the scheduled meeting of the National representative Assembly (NRA) on November 14, 2024. (Article IV Section 4). However, the NRA for this year will be held on December 13, in view of the Gala Night on December 12, 2024.
2. During the RRA, the Sole Regional Representative to the National PPSTA Board of Trustees shall be elected for nomination. (Article VI Section 7).
3. During the RRA, the PPSTA COMELEC nominee shall be selected and submitted to be elected during the NRA.
4. The RRA shall also select and submit the names of their nominees for Independent Trustee, wherein one (1) is a lawyer, one (1) is an Accountant, and the other one (1) is a Department of Education retiree. The National PPSTA Board of Trustees shall select from among the nominees one (1) from Luzon, one (1) from Visayas, and one (1) from Mindanao.
5. The RRA shall nominate one of their members to the Oversight and Audit Committee. The National PPSTA Board of Trustees, shall select the three (3) members of the Oversight and Audit Committee from among the nominees, one (1) from Luzon, one (1) from Visayas, and one (1) from Mindanao.
6. The RRA shall elect their respective their respective Regional Officers and constitute their Regional Delegation to the NRA.
7. The SOLE Regional Representative nominee to the National PPSTA Board of Trustees, the PPSTA COMELEC member nominee, the Independent Trustee nominees, and the Oversight and Audit Committee nominee and the Regional Officers shall have the following qualifications:
 - a. An active regular member for the last five years on the date of the election, and
 - b. Must not have been convicted of a crime involving moral turpitude, and
 - c. No person shall serve as an Independent Trustee unless they are of good moral character, unquestioned integrity and recognized competence.
 - d. The regional Officers and official delegates and their proxies, and even observers to the NRA shall have the same qualifications.
8. The RRA maybe conducted in-person or virtually as the case maybe.

9. Election issues in the RRA shall be settled in that level. Only unresolved issues shall be forwarded to the PPSTA COMELEC. A proof of their deliberations shall be attached to their referral.

10. The names of the delegates chosen by the local chapters shall be submitted to the PPSTA main office not later than thirty (30) days prior to the NRA which is on November 13, 2024.

11. A certification from the Regional President that their nominees and members of the delegation are qualified as required.

12. The Regional Chapters that will elect their SOLE Regional Representative as nominee to the NRA are the following:

- a. Region 3
- b. Region 4A
- c. Region 5
- d. Region 7
- e. Region 8
- f. Region 9
- g. Region 12
- h. CARAGA Region 13
- i. NCR

13. Nominees for National PPSTA Board of Trustees and PPSTA COMELEC shall be given one (1) minute to introduce themselves.

14. It should be noted that since this is a NRA elections delegates are encourage to vote for National PPSTA Board of Trustees nominees from other Regions.

15. Delegates shall also vote for PPSTA COMELEC nominees, one (1) from Luzon, one (1) from Visayas, and one from Mindanao.

16. The election this year is automated. We will be using desktops for the three precincts that will be set up and mobile phones of the delegates. As such, the delegates have two options to choose from.

17. Using these two platforms will dramatically shorten the duration of the election, however, ballots, tally sheets, pens and ballot boxes will be prepared as a back-up in case there is an interruption in internet and power connectivity.

18. The PPSTA COMELEC through the deputized PPSTA employees will send links to the registered qualified delegates to their respective electronic mail addresses that include their respective usernames and passwords.

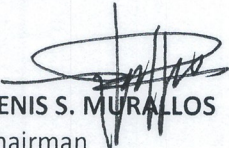
19. The links will be activated at the start of the elections.

20. Deputized PPSTA employees will be available to assist delegates in using both the desktop and their mobile phones to facilitate the casting their votes.

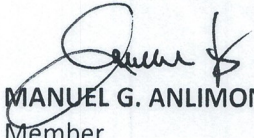
21. The duration of the election, from casting of votes to the proclamation of winners is one hour. The link will be deactivated after one hour or earlier if all the delegates have already casted their votes.

22. The results will be printed and the proclamation of winners will immediately follow.
