(Resolution Approving the Appointment of the Compliance Officer)

WHEREAS, the Personnel Committee recommended the appointment of Mr. Arturo Caño as Compliance Officer of the Association for having met the qualifications and passed the evaluation of the Committee;

WHEREAS, the appointment of Mr. Caño as Compliance Officer shall be subject to the following roles and responsibilities:

- a. Develop and implement compliance programs and procedures;
- b. Ensure PPSTA's compliance with all applicable laws, regulations, and internal policies;
- c. Serve as liaison with regulatory authorities (DepEd, SEC, BIR, IC, LGU, DOLE, SSS, PhilHealth, etc.), and stay updated on regulatory changes;
- d. Act as the primary point of contact for all government agencies and offices on compliance issues and concerns;
- e. Provide training and guidance to employees on compliance-related matters;
- f. Report compliance activities and findings to the General Manager; and
- g. Perform other related duties as may be assigned by the General Manager and/or Board of Trustees.

WHEREAS, the Board of Trustees recognizes the necessity of designating a Compliance Officer in order to ensure that PPSTA maintains proper compliance with applicable laws, rules, regulations, and directives of regulatory agencies;

WHEREAS, the Board of Trustees finds the recommendation of the Personnel Committee to be proper and in the best interest of the Association;

NOW, THEREFORE, for and in consideration of the foregoing premises, BE IT RESOLVED as it is hereby **RESOLVED** that the Board approves the appointment of Mr. Arturo Caño as Compliance Officer of PPSTA, reporting directly to the General Manager and/or Board of Trustees, effective 01 July 2025.
